Subject: Re-advertisement of Three (03) Vacant Reserved Seats for Sons/Daughters of Practicing Lawyers for Admission in First-Year LL.B. Batch 2026

In pursuance of the approval granted by the Honorable Vice Chancellor Engr. Prof. Dr. Madad Ali Shah, and in continuation of this department's letter SBBU/Dept./Law/160 - Dated: December 24, 2025, it is hereby notified that the three (03) seats reserved for **real sons/daughters of practicing lawyers** in the First-Year LL.B. program (Batch 2026) are hereby re-advertised for fresh applications.

Eligibility & Conditions:

1. Only **real sons/daughters of practicing lawyers** who have qualified the LAT (Law Admission Test) are eligible to apply under this reserved category, as per **PBC Legal Education Rules 2015, Rule 4 (iii)**.
2. Candidates applying under this category must:
 - o Duly fill and submit the attached application form.
 - o Provide a photocopy of their parent's **Pakistan Bar Council (PBC) Registration Certificate** or **valid practicing license** at the time of interview. Failure to submit this document will result in ineligibility for the reserved quota.
3. Candidates who **earlier applied but were not shortlisted for interview are not eligible** to apply again under this re-advertisement.
4. New candidates, including those who were previously registered but **failed to pay the registration fee**, may apply.
5. Applicants must submit a **non-refundable registration fee of Rs. 3,000/-** along with the application.

Note: Candidates who do not qualify for the reserved category may also apply. In case the number of eligible reserved-category applicants is less than three, the remaining seat(s) will be **converted to open merit**, and all applicants (including non-reserved) will be considered on merit.

Application Procedure:

- Applications must be submitted **by Friday the January 2nd, 2026**.
- Applications should be submitted **online only** through the official website of the SBBU-SBA: <https://www.sbbusba.edu.pk>.

- A **revised and final merit list** will be issued to fill any remaining seat(s).
